### COVID-19 Vaccine Certificate Program

October 29, 2021

To stop the spread of COVID-19 and keep Ontario's businesses and services open, the province has begun a new public health measure. **Beginning September 22**, you need to show proof of vaccination to enter certain businesses and settings.

#### Where do I need to show proof of vaccination?

As of September 22, you need to show proof of vaccination to enter some non-essential spaces. These are public settings and businesses where it may not be possible to wear a mask all the time:

- Restaurants and bars
- Nightclubs
- Meeting and event spaces
- Fitness and recreation centres
- Sport and racing events
- Casinos, bingo halls and gaming venues
- Concerts and movie theatres

#### What 'proof' do I need to show?

You will need to show proof that you have received two doses of a COVID-19 vaccine. And that the second dose was received at least 14 days prior to entry.

Many people received a vaccine receipt at a clinic. This receipt shows the following information:

- Name
- Date of birth
- Last 4 digits of your health card
- Name of the vaccine
- Lot number
- Dose
- Site and time given
- Health authority

You will need to show a print or digital copy of your vaccine record for your second dose. And one piece of personal i.d. to verify your identity.

### What pieces of identification are accepted?

The piece of i.d. that you use should have your name and birthday on it. You do not need to show photo i.d. You could use:

- Status card/Indigenous membership card
- Government issued identification like a health card
- Driver's license
- Passport
- Birth certificate
- Citizenship or permanent residency card

### I have heard there are different documents you can show as proof of vaccination. Is this true?

There are two forms of proof that are accepted across Ontario.

1. A paper or digital copy of your vaccine record from the Ministry of Health
2. The enhanced vaccine certificate with official QR code

The enhanced vaccine certificate with QR code was introduced on October 15, 2021. This enhanced certificate is secure and private. It generates a QR code that is yours alone. Businesses and services will use an app that can read these QR codes and verify your vaccine status. You will still need to show a piece of i.d.

**Paper copies of vaccine records are still accepted.**

### Where can I access my vaccine records?

There are a few different ways you can get a copy of your vaccine records.

For the Northwestern Health Unit, you can call 807-468-3147. If you call outside of work hours, the number is 807-468-7109.

For the Thunder Bay District Health Unit, you can call 807-625-5900. If you call outside of work hours, the number is 807-625-7451.

### **What if I have a medical exemption?**

If there is a medical reason why you cannot get vaccinated at this time, you should speak with your healthcare provider. They can provide you with a document that you can show to enter public spaces.

### **Who needs to show proof of vaccination?**

This new measure applies to anyone who is 12 years of age or older.

### **What if I am not fully vaccinated?**

If you are not fully vaccinated, you won't be able to access businesses and settings like the ones listed above. But you can still choose to get vaccinated against COVID-19. You can call your nursing station or healthcare provider to learn when the next vaccine clinic will be.

### **What if I am attending a wedding or funeral?**

If the wedding or funeral is being held in a public event space or a place of worship, guests will need to show proof of a second dose and a piece of personal i.d. to attend.

### **Do I need to show proof of vaccination when I travel?**

Beginning on October 30<sup>th</sup>, 2021, anyone travelling on a plane or train will need to be fully vaccinated and show proof of their second dose to board. This also applies to anyone travelling on a marine vessel for more than 24 hours (e.g., cruise ship).

## FREQUENTLY ASKED QUESTIONS

There will be a transition period. Until November 30<sup>th</sup>, you can show a negative COVID-19 test result to board. The test must be completed within 72 hours of your travel. After November 30<sup>th</sup>, all passengers will need to be fully vaccinated.

Engagement with community leadership is on-going to help ensure that community members have access to essential services.

Many provinces are running similar certificate programs. If you are travelling to Manitoba, you can use your Ontario vaccine records and i.d. to get access to businesses and public events.

### How long will I need to show proof to get in places?

It is unclear how long this program will last. But it is intended as a temporary measure to slow the spread of the virus and help keep businesses open during the fourth wave of the pandemic. Until we learn more, it is recommended that you keep a copy of your vaccine records with you.
